# Georgia Bio Legislative Report March 1, 2021

Legislative Days 20 - 24

## **GENERAL UPDATE:**

The Georgia Made Medical Manufacturing Act (originally <u>House Bill 304</u>) made progress this week after being added to a third piece of legislation. <u>House Bill 587</u>, the Georgia Economic Renewal Act of 2021 carried by Rep. Bruce Williamson (R – Monroe), was dropped last Monday including the language for the pharmaceutical and medical supply manufacturing tax incentive. This bill passed out of the House Ways & Means Income Tax Subcommittee on Wednesday before being passed out of full committee on Thursday.

The new legislative calendar that was adopted on Friday sets Crossover Day for next Monday, March 8<sup>th</sup>. This means that House Bill 587 will need to be passed on the House Floor by this day to still be considered for final passage this legislative session. We are very optimistic that the bill will be on the floor either Wednesday or Friday of this week but will not know for sure until the Rules Calendars for those days are set (always set the legislative day before). We will provide updates on our social media platforms and via email about the bill's progress and hopeful passage in the House before beginning the process over again in the Senate.

As mentioned above, a new adjournment resolution was also adopted on Friday outlining the remaining 16 legislative days of the 2021 session. This new resolution sets the date for Sine Die, the final day of the legislative session, on Wednesday, March 31<sup>st</sup>.

#### HB 587; Georgia Economic Renewal Act of 2021

Bill Author: Rep. Bruce Williamson (R - Monroe)

Bill Status: House Rules

**Summary:** HB 587 is a tax incentive package containing the language from the Georgia Made Medical Manufacturing Act (HB 304). The portion we are following would implement a tax credit for pharmaceutical and medical supply manufacturing operations in Georgia.

HB 637; Require continued mask/facial protection for 12 months following conclusion of a public health emergency

Bill Author: Rep. Spencer Frye (D - Athens)

Bill Status: House Health & Human Services

**Summary:** HB 637 would authorize persons to wear masks, hoods, or other devices to prevent the spread of a contagious or infectious disease during and for 12 months following the conclusion of a public health emergency.

#### SB 181; Reduce out-of-pocket insulin costs

**Bill Author:** Sen. Jen Jordan (D - Atlanta)

**Bill Status:** Senate Health & Human Services



**Summary:** SB 181 relates to insurance provisions to reduce out-of-pocket cost of consumers requiring insulin. This is a companion bill to House Bill 73.

# **COVID PROTOCOLS FOR VISITING THE STATE CAPITOL:**

To ensure the safety of those working and visiting the State Capitol, the following safety protocols have been implemented:

- Thermal temperature checks at public entrances
- · Sanitizing stations throughout building
- Directional guides to minimize crowd flow
- Masks strongly encouraged

Capitol staff has also requested that you only come to the building for specific business and do not linger so as to keep crowding in the halls to a minimum.

# **CAPITOL COVID-19 TESTING FOR LOBBYISTS**

Testing in the Sloppy Floyd building is now available to lobbyists, elected officials, staff and the public. Tests will be administered in room 404 on the balcony level of the west tower of the Floyd building (up the escalator to your left). This site will be open from 10am-2pm Monday-Friday. This testing site will be available throughout session.

**Site Code: GASTATEC** 

This system allows for both pre-registration and results access. Once registration is complete, a form will be emailed and can be printed. Registrants should bring the form, a copy of their ID/Driver's License and insurance card if they have insurance. If the registrant is uninsured, they can select uninsured as a payment option. These uninsured claims will be billed to the CARES Act. Once results have been finalized and released, an email will be sent to registrant notifying that results are ready. They can then log in using the site code and confirmation number generated after successful registration.

Walk ups are also welcome.

#### **VACCINE UPDATE:**

On Thursday, Governor Kemp announced that the addition of pre-k – 12 educators and staff, adults with intellectual and developmental disabilities and their caregivers, and parents of children with complex medical conditions to COVID vaccine distribution beginning March 8<sup>th</sup>. Gov. Kemp also announced that Georgia would no longer follow the original phased approach but would instead add groups as the supply increased and allowed. The next group expected to be added to this list are the medically fragile or immunocompromised under 65, however this has not been officially announced. We will continue to monitor the progress of supply and maintain our communications with the Governor's office.
