

Georgia Bio Legislative Watch January 18, 2022 Days 1-4 of 40 Day Session

GENERAL INFORMATION:

The Georgia Legislature convened the 2022 Legislative Session on Monday, January 10th. The House and Senate approved the calendar for the first 7 days of the annual 40-day legislative session, taking us through January 26th.

Budget Week is scheduled for this week with Joint House and Senate appropriations meetings convening on the mornings of the 18th through the 21st. Those budget hearings will all be available for virtual viewing and will be devoted to the FY2022 continuation budget and the FY2023 General Appropriations Act. Georgia Bio will closely monitor these meetings to ensure funding for our Rural Teacher Training Initiative (RTTI) is secured for the program's fourth year.

2022 Joint Budget Hearings Schedule

Gov. Brian Kemp delivered his fourth State of the State address on Thursday, January 13th, outlining his vision for the coming year. One of his goals for the amended FY2021 and FY2022 budgets will be to adjust spending to pre-Covid budget cut levels, beginning with fully restoring funding for the Department of Education and issuing the final \$2,000 per teacher pay increase to fulfill his promise of \$5,000 raises to Georgia's teachers. Access to quality and affordable healthcare will also be a top priority with funding to add an additional 1,300 practitioners to Georgia's rural areas to support the workforce shortages.

COVID PROTOCOLS FOR VISITING THE STATE CAPITOL:

To ensure the safety of those working and visiting the State Capitol, the following safety protocols have been implemented:

- Thermal temperature checks at public entrances
- Sanitizing stations throughout building
- Directional guides to minimize crowd flow
