

### Georgia Bio Legislative Watch January 24, 2022 Budget Week Update

### **GENERAL INFORMATION:**

Each January the governor proposes two distinct budgets. The amended budget for FY 2022 adjusts spending levels for the current fiscal year and the full budget for FY 2023 lays out a new spending plan for the upcoming fiscal year. Governor Kemp's FY 2023 budget proposal seeks to bring Georgia back to pre-COVID funding levels, including full restoration of the Department of Education budget.

The week after the first week of session is always reserved for Budget Week where representatives from the various state agencies present their proposed budgets before Joint Sessions of the House and Senate Appropriations Committees. Georgia Bio is closely following the House Education Subcommittee discussions as our Rural Teacher Training Initiative (RTTI) funding is housed in the Department of Education budget.

### **RURAL TEACHER TRAINING INITATIVE (RTTI) UPDATE:**

The Rural Teacher Training Initiative was created in 2019 to support the growth of the life science workforce and improve opportunities for young people in rural communities. After the 2020 round of budget cuts reduced our funding, we were thrilled to see our funding restored to the full \$323,000 in last year's FY 2022 budget.

In addition to the funding restoration, the program was moved within the Department of Education from the Career, Technical and Agricultural Education (CTAE) to the Innovative Programs and Research division.

RTTI is a collaboration among the Georgia Department of Education, the Georgia BioEd Institute, the Technical College System of Georgia, the University of Georgia, and Georgia Tech, as well as the Georgia life science industry. Despite the necessary pivot due to COVID protocols, RTTI delivered cutting edge training and equipment for secondary science teachers in four virtual sessions led by master instructors. The training provides educators with laboratory experiences that they can replicate in the classroom and offer instruction that aligns with the Georgia Standards of Excellence and prepares and

inspires students to enter a career in life sciences.

#### SB 317; Authorize physicians to delegate authority to dispense prepackaged medications
